After losing her sister in a house fire as a child, Joelle Maryn experienced spiritual amnesia, losing her identity in the aftermath of the tragedy that shook her family to the core. Joelle went on to find worldly success, modeling for well-known brands such as Jergens, having a billboard in Times Square, appearing in independent films, and hosting ABC-5's "Trend TV." She also developed a luxury line of anti-aging makeup that was featured on NBC and in Vanity Fair. Despite all this, she realized her life was spiritually empty and joyless.

In 2012, Joelle had a miraculous encounter with Jesus and in His mercy, was given another chance to love and lead others to Him. The fire of God illuminated her true identity and enabled her to walk in the newfound power of knowing that she had a deeper purpose.

Joelle now shares her message of healing around the world, empowering others to walk with God to rediscover joy and purpose in their lives. Harnessing the power of media to evangelize, Joelle engages in faith-based, inspirational, and family-friendly films, TV shows, and other on-camera projects to lead others closer to Christ.

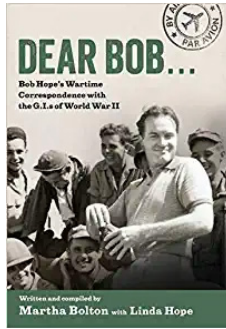


Book Review

Dear Bob...Bob Hope's Wartime Correspondence with the G.I.s of World War II

Written and compiled by Martha Bolton with Linda Hope • University Press of Mississippi, Jackson, MS 2021 • 306 pages hardbound



In May 1941, two thousand servicemen crammed into the gymnasium at March Field in Riverside, California. The temperature was 94 degrees – this was before central air conditioning – they were there because Al Capstaff, the Producer for Bob Hope's popular radio show, had talked Bob into broadcasting a show from the March Field gymnasium with Frances Langford, Bing Crosby, Jerry Colonna, the Skinnay Ennis band, and announcer Bill Goodman.

The effect Bob Hope had on that eager, laughter-starved audience in the middle of the desert was thunderous by all accounts, but no less was the effect those two thousand had on Bob Hope.

On December 7th Pearl Harbor was bombed and Bob Hope's destiny as an entertainer of servicemen and women was sealed.

For the rest of WWII Hope and a small but quality troupe of entertainers traveled the world putting on USO shows to lift the morale of the troops. Travel in war zones was hazardous, but crashes and artillery barrages couldn't prevent Hope and his troupe from putting on performances for audiences both large and small, and visiting the wounded in field hospitals.

Bob Hope was popular and received as many as 38,000 pieces of fan mail a week by 1944 from G.I.s who had seen his shows (as many as 58 performances in eight days!).

"Dear Bob" is a collection of these letters, and through them I learned quite a bit about Bob Hope, but far more about the people who wrote those letters – not only of soldiers and the wounded, but of their wives and mothers thanking Bob for the laughter he gave to their husbands and sons who wouldn't return from the war.

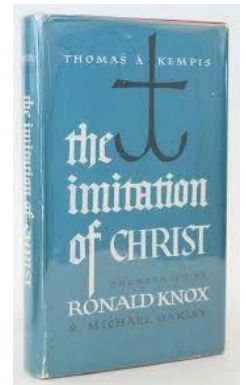
This is a worthwhile book – full of humorous anecdotes as well as heart wrenching emotion

The first part of this series of quotations from "The Imitation of Christ" was in our October 2021 Newsletter. This article continues some brief passages from Book One, Practical advice about the spiritual life.

As a reminder, this is a book written by a West German priest six centuries ago. It remains to be the second widely read spiritual book next to the Bible.

From Chapter 11B about the ambition to do better:

"We hear of Saints who reached the heights, and became great contemplatives; how did they manage it? They made it their business to wean themselves away from all earthly desires; this left them free to cling, with every fiber of their hearts, to God, and attend to the business of their souls." . . . "You must begin by saying No to your inclinations, getting out of bad habits, or they will involve you in worse trouble as time goes on. If you could but realize what a difference it makes, a life well lived, the peace of mind it would bring you, the encouragement it would give others! I can't help thinking you would be more concerned about your progress in the spiritual life."

Speaker Recap: Lisa Smittcamp

“Blessings come from living your faith,” asserted Lisa Smittcamp at the October breakfast. Lisa has been Fresno County’s District Attorney since 2015. People often tell her she is being prayed for, and she relates that she feels it. She likens prayer to an iPod one must plug in at night, asking God where he wants you to be, rather than praying for what you think you need.

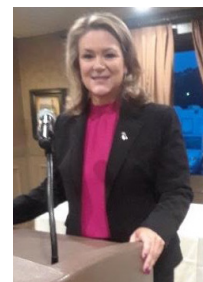
Lisa reports that being DA has opened her eyes to others’ perspectives. She tries to teach young prosecutors who is redeemable, and that it is OK to show grace even in difficult situations. In correspondence she will often ask, “If you are a person of faith, please pray.” She reports many positive relationships with area pastors. She has lectured at Fresno State for ten years and oversees some mentoring projects through the DA’s office.

As a result of her brother’s problems as a former addict, Lisa says she has become more compassionate. She is anti-marijuana because she has seen how too often it has been a gateway drug. “We need to fight for families and faith,” she asserts, addressing the breakdown of the family, a falling away from traditions, and lack of

structure. Fatherless homes without positive role models have become a tragedy, and there is often a lack of parenting, wanting instead to be a child’s friend, resulting in an entitlement attitude among children who grow up without accountability or responsibility.

Lisa emphasized the local opioid crisis which she states should be everyone’s concern and urges watching the recent Channel 30 documentary, “Killer High: the Silent Crisis,” on the seriousness and high death rate from the drug Fentanyl.

She has been a strong advocate against violence toward women and children, animal cruelty, violent crime, and for veterans’ rehabilitation. Unlike some DAs, she often assigns herself to important cases. Prior to election to her current position, the USC graduate was an assistant DA in Fresno and Madera Counties and spent a year in civil practice. She serves on the boards of several community organizations.



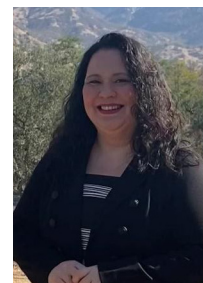
Business Person of the Month: Julia Fracker

Born to a military family, Julia Fracker, spent her childhood moving around the US. Julia’s father entered the Catholic Church when she was 11, and she followed at 17. She returned to the Church with a renewed energy through an ACTS retreat in 2007. She ended her abusive relationship and combined her newfound passion for the Faith with her love of learning.

Julia went on to receive an MA in Theology and a Graduate Certificate in Catholic School Administration. She has since worked in full-time ministry, serving in parishes and schools in three dioceses. She currently works in Marketing and Development at St. Anthony Retreat Center and teaches for the Diocesan Lay Formation Institute.
